

ACCEPTABLE Identification Documents

Mandatory for all background services

To apply for a badge and/or have fingerprints taken at John Wayne Airport all applicants must present two (2) forms of valid ID. All acceptable documents are listed below; only the original or certified copy (if stated below) will be accepted. All documents must be valid (**not expired**). ID combination choices are:

1. One ID from each list "A" and "B"
2. One ID from each list "A" and "C"
3. One ID from each list "B" and "C"

Required ID Examples itemized by your status in the US: "Non-drivers may supply an ID card in lieu of a Driver's License (DL)"

- a. US Born: DL and Social Security Card, Birth Certificate, or US Passport.
- b. Born Abroad as US Citizen: DL and Birth Certificate Abroad or US Passport.
- c. Born in another Country: DL and Employment Card, Resident Card, or Visa with I94.
- d. US Citizen Naturalized: DL and US Passport or Naturalization Certificate.

In case of a nonimmigrant alien authorized to work for a specific employer incident to status, a foreign passport with Form I-94 or form I-94A bearing the same name as the passport and containing an endorsement of the alien's nonimmigrant status, as long as the period of endorsement has not yet expired and the proposed employment is not in conflict with any restrictions or limitations identified on the form. 6. Passport from Federated States of Micronesia (FSM) or the Republic of the Marshall Islands (RMI) with Form I-94 or Form I-94A indicating nonimmigrant admission under the Compact of Free Association Between the United and the FSM or RMI 	<ol style="list-style-type: none"> 1. Employment authorization document issued by the Department of Homeland Security.

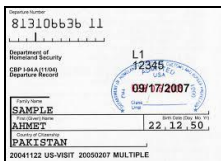

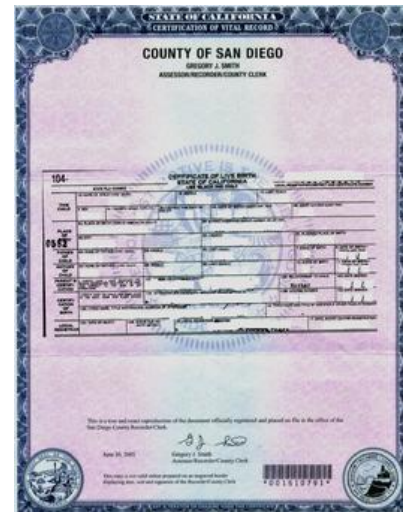

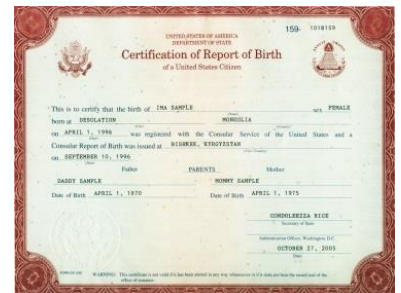
