7.0 Persons Consulted

7.1 AGENCY COORDINATION

In 2015, as part of the preliminary effort for the General Aviation Improvement Program ('GAIP") the John Wayne Airport ("JWA" or "Airport") staff met with the general aviation tenants and stakeholders to identify issues the general aviation community would like addressed and priorities for making improvements. In addition to a general discussion, the Airport staff asked the following questions:

- Are your business/client needs currently being accommodated according to the high standards upheld by your company and by JWA? If not, what can JWA do in its future planning (the general aviation Airport Layout Plan Update) to restore and maintain those high standards?
- What are your organization's three chief priorities regarding a potential future at JWA? What can JWA do to address those priorities?
- What other items would you like to bring to the Airport's attention?

These meetings are listed and briefly summarized in Table 7-1.

In addition to the meetings identified in Table 7-1, AECOM, which was retained by the County of Orange to provide Preliminary Engineering services for the GAIP, also conducted outreach to the various stakeholders at JWA. This effort included interviews with the FBOs and stakeholders, and posting an online survey with based aircraft owners using a contact list provided by the Airport. The purpose was to assist in the process of evaluating and planning for the future needs of the general aviation community. Interviews were conducted on November 11, 14, and 15, 2016 with the following stakeholders:

These meetings are summarized in the FBO/Stakeholder and Based Aircraft Owner Survey Report, which is available for review at the Airport offices located at 3160 Airway Avenue, Costa Mesa, California 92626. The Survey Report includes stakeholder and FBO interview notes, a summary of statistics on the based aircraft owner survey and findings, copies of all responses from stakeholders and FBOs for the survey questions and copies of the responses collected from the based aircraft owner survey.

7.2 Public Outreach

In addition to stakeholder meetings, a public Scoping Meeting was conducted in conjunction with the release of the Notice of Preparation ("NOP") for this Program EIR. The Scoping Meeting was held on April 12, 2017, from 6:00 to 8:00 PM at the JWA Administrative Office in the Airport Commission Meeting Room to facilitate agency and public review and comment on the GAIP. A hand-out, which provided an overview of the GAIP to be evaluated in the Program EIR and a list of frequently asked questions, was distributed at the Scoping Meeting. The NOP of the Draft Program EIR for the GAIP was distributed to 75 individuals or agencies and to the State Clearinghouse and other public agencies on March 30, 2017, for the required 30-day review and comment period. In addition, email notices regarding the availability of the NOP on the JWA website were sent to all the lessees at the Airport; and the NOP was posted on the JWA website, as well as the County of Orange Public Works website. The NOP and distribution list, as well as the comments received are provided in Appendix A of this Program EIR. In addition, the issues raised in the comments in responses to the NOP are summarized in Table 2-1, provided in Section 2.3.2 of this Program EIR.

The Draft Program EIR will be circulated for a 45-day public review period. During the public review period, an open house will be held to receive comments from the public regarding the GAIP. The meeting is scheduled for May 17, 2018, as part of the public review period, there will be a public meeting. The meeting will be held at 6:00 P.M. at the JWA Administrative Offices, in the Airport Commission hearing room. Upon completion of the public review period, written responses to all significant environmental issues raised will be prepared and made part of the Final Program EIR for consideration by decision-makers for the GAIP.

7.3 TECHNICAL OUTREACH

Prior to preparing the Traffic Impact Analysis for the GAIP, the transportation consultant (Austin Transportation Consulting [ATC]) and Airport staff met with the traffic engineers for the adjacent cities to discuss the approach to the traffic. An overview of the GAIP was presented by the Airport. These meetings are summarized in Table 7-2.

7.4 NATIVE AMERICAN OUTREACH

In December 2016, tribal consultation was initiated consistent with the requirements of AB 52 and SB 18. In connection with this consultation effort, the County of Orange sent letters to tribes that have expressed an interest in being consulted regarding Native American resources for the projects being undertaken in unincorporated Orange County. Letters were sent to the:

- Gabrielino Band of Mission Indians Kizh Nation
- Juaneño Band of Mission Indians Acjachemen Nation
- San Gabriel Band of Mission Indians
- Soboba Band of Luiseño Indians

In January 2017, the County received one response from Mr. Salas (Tribal Chair), for the Gabrielino Band of Mission Indians – Kizh Nation. Follow on coordination with Mr. Salas was conducted in February and December 2017. This coordination effort is discussed further in Section 4.9, Tribal Cultural Resources.
