JOHN WAYNE AIRPORT POSTS AUGUST 2019 STATISTICS

SANTA ANA, Calif. - Airline passenger traffic at John Wayne Airport decreased in August 2019 as compared with August 2018. In August 2019, the Airport served 942,541 passengers, a decrease of 4.9% when compared with the August 2018 passenger traffic count of 991,112.

Commercial aircraft operations decreased 6.1% and commuter aircraft operations increased 128.0% when compared with August 2018 levels.

Total aircraft operations decreased in August 2019 as compared with the same month in 2018. In August 2019, there were 29,921 total aircraft operations (take-offs and landings), a 2.3% decrease compared to 30,621 total aircraft operations in August 2018.

General aviation activity, which accounted for 71.9% of the total aircraft operations during August 2019, decreased 2.5% when compared with August 2018.

The top three airlines in August 2019 based on passenger count were Southwest Airlines (288,402), American Airlines (162,193) and United Airlines (154,863).

JOHN WAYNE AIRPORT POSTS SEPTEMBER 2019 STATISTICS

SANTA ANA, Calif. - Airline passenger traffic at John Wayne Airport increased in September 2019 as compared with September 2018. In September 2019, the Airport served 859,174 passengers, an increase of 0.3% when compared with the September 2018 passenger traffic count of 856,688.

Commercial aircraft operations decreased 3.2% and commuter aircraft operations increased 88.6% when compared with September 2018 levels.

Total aircraft operations decreased in September 2019 as compared with the same month in 2018. In September 2019, there were 26,218 total aircraft operations (take-offs and landings), a 6.3% decrease compared to 27,987 total aircraft operations in September 2018.

General aviation activity, which accounted for 69.8% of the total aircraft operations during September 2019, decreased 8.6% when compared with September 2018.

The top three airlines in September 2019 based on passenger count were Southwest Airlines (275,410), American Airlines (142,219) and United Airlines (138,707).

JOHN WAYNE AIRPORT POSTS OCTOBER 2019 STATISTICS

SANTA ANA, Calif. - Airline passenger traffic at John Wayne Airport decreased in October 2019 as compared with October 2018. In October 2019, the Airport served 897,873 passengers, a decrease of 1.0% when compared with the October 2018 passenger traffic count of 907,191.

Commercial aircraft operations decreased 5.2% and commuter aircraft operations increased 84.4% when compared with October 2018 levels.

Total aircraft operations decreased in October 2019 as compared with the same month in 2018. In October 2019, there were 25,468 total aircraft operations (take-offs and landings), a 5.4% decrease compared to 26,926 total aircraft operations in October 2018.

General aviation activity, which accounted for 67.9% of the total aircraft operations during October 2019, decreased 6.9% when compared with October 2018.

The top three airlines in October 2019 based on passenger count were Southwest Airlines (288,850), American Airlines (150,471) and United Airlines (143,338).

Subject: NOI to Adopt an IS/MND for Van's Headquarters Expansion

Dear Mr. Inloes:

Thank you for the opportunity to review the Draft Mitigated Negative Declaration (MND) for the Van's Headquarters Expansion located at 1588 South Coast Drive, Costa Mesa, in the context of the Airport Land Use Commission's *Airport Environs Land Use Plan for John Wayne Airport (JWA AELUP)*. The proposed project includes the construction of a three-story, 91,032 square foot office building and a three-story parking structure. The project would also include ancillary outdoor improvements (a small amphitheater and a half-pipe skate ramp) for Van's employees only.

The proposed project is located within the Federal Aviation Regulation (FAR) Part 77 Notification Area for JWA. We suggest that the MND discuss the height at which the notification surface would be penetrated compared to the proposed building heights. We recommend that the project proponent utilize the Notice of Proposed Construction or Alteration (NOI) Tool on the Federal Aviation Administration (FAA) website <https://oeaaa.faa.gov/oeaaa/external/protal.jsp> to determine if the proposed project penetrates the notification surface and requires filing Form 7460-1 Notice of Proposed Construction or Alteration with the FAA.

Subject: City of Costa Mesa Permanent Bridge Shelter Facility

Dear Mr. Curtis:

During the meeting held August 15, 2019, the Airport Land Use Commission (ALUC) for Orange County considered the subject project. The matter was duly discussed, moved, seconded and carried by a vote of 5-2 by the Commission to find the City of Costa Mesa's proposed Permanent Bridge Shelter Facility, located at 3175 Airway Avenue, to be consistent with the Commission's *Airport Environs Land Use Plan (AELUP) for John Wayne Airport (JWA) and the AELUP for Heliports* with the inclusion of the following:

1. That the City agrees to refer to the ALUC any Conditional Use Permit requests for shelters in the Industrial Park (MP) zone.
2. The City agreeing to Grant an Avigation Easement to the County of Orange covering noise impacts and allowing the overflight of aircraft over this particular project.
3. The City will submit for review, the final noise report after sound attenuation.
