RE: Change to Passenger Facility Charge Expiration Date for PFC Application 06-01-C- 00 SNA to January 1, 2024

Dear Air Carrier Representative,

This letter is to notify all PFC collecting carriers at John Wayne Airport (SNA) Orange County, California, of a change to the Charge Expiration Date for PFC Application 06-01-C-00-SNA to **January 1, 2024**.

The Coronavirus Pandemic outbreak devastated the airports and air transportation industry, resulting in an unprecedented decline in airport traffic and passenger activity. Consequently, John Wayne Airport in Orange County, California (SNA) experienced a substantial shortfall in PFC receipts. We anticipate that a 24-month extension to the PFC collection period will allow the Airport to recover from the significantly lower than anticipated PFC collections. The Airport plans to submit a new PFC Application to the FAA before the PFC extension expires.

Please notify your PFC collecting agent accordingly.
