RECOMMENDED ACTION(S):

Approve the recommended revisions to the John Wayne Airport Arts Commission Bylaws.

SUMMARY:

John Wayne Airport requests approval of the proposed revisions to the John Wayne Airport Arts Commission Bylaws to achieve consistency with the Bylaws Template approved by the Board of Supervisors.

BACKGROUND INFORMATION:

Establishment and Authority

On January 16, 1990, the Board created the JWA Arts Commission (Airport Arts Commission) according to Board Resolution No. 90-96 (Resolution). The Resolution established a five-member commission appointed by the Board to provide advice and recommendations to the Airport Director and Board regarding the development, finance and administration of the Airport Arts Program.

Board Directive for Bylaws Template

On May 25, 2021, the Board approved the Boards, Commissions, and Committees (BCC) Bylaws Template proposed by County Counsel. The action taken by the Board directed County departments to review existing bylaws for BCCs under the Board's jurisdiction and seek Board approval of revised bylaws that include the elements contained in the BCC Bylaws Template. On July 13, 2021, the Board approved a revised bylaws template consistent with changes to Board Rules of Procedure relating to at-large nominations and deleted or continued Board agenda items.

Airport Actions and Proposed Revisions

JWA reviewed the existing bylaws for the Airport Arts Commission, dated March 2, 2016. The Airport Arts Commission reviewed and approved the revisions to the bylaws on April 6, 2022. The goal of the modifications to the Airport Arts Commission Bylaws is to clarify elements consistent with the BCC Bylaws Template approved by the Board.

JWA requests the following exceptions to the BCC Bylaws Template:

- Article IV.C.2. for at-large member appointments. The Airport Arts Commission is composed of five regular members nominated by each member of the Board. JWA requests that committee appointments are limited to regular members.
- Article VI.B. for making a notification of any expected meeting absence. JWA requests that committee members making a notification for a meeting absence be expanded from the Chairperson to the Chairperson and Clerk for the Airport Arts Commission. The expanded notification process will facilitate the determination of a quorum.
- Articles VII.B. and VII.D. for standing committees and subcommittees. The proposed Bylaws permit the Chairperson to establish Ad-Hoc Committees for the period of time required to fulfill the Ad-Hoc Committees' purpose. Standing committees and subcommittees are not considered necessary because an option exists for an Ad-Hoc Committee.

Compliance with CEQA: This action is not a project within the meaning of CEQA Guidelines Section 15378 and is therefore not subject to CEQA, since it does not have the potential for resulting in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment. The approval of this agenda item does not commit the County to a definite course of action in regard to a project since the action authorizes approval of revisions to the Airport Arts Commission Bylaws to achieve consistency with the BBC Bylaws Template approved by the Board on May 25, 2021. This proposed activity is therefore not subject to CEQA. Any future action connected to this approval that constitutes a project will be reviewed for compliance with CEQA.

BYLAWS JOHN WAYNE AIRPORT ARTS COMMISSION CREATED BY ACTION OF BOARD OF SUPERVISORS AMENDED [INSERT DATE]

ARTICLE I. Name of Organization

- A. The name of this organization shall be John Wayne Airport Arts Commission, hereinafter referred to as "Airport Arts Commission."
- B. The official location and mailing address of the Airport Arts Commission shall be:

ARTICLE II. Establishment of John Wayne Airport Arts Commission

The members of the Airport Arts Commission are appointed by the Orange County ("County") Board of Supervisors ("Board") pursuant to Board Resolution No. 90-96, dated January 16, 1990.

ARTICLE III. Purpose and Functions

The purpose and function of the Airport Arts Commission is to advise and make recommendations to the Airport Director and Board regarding the development, finance, and administration of the Airport Arts Program.

ARTICLE IV: Appointment and Membership

- A. Membership of the Airport Arts Commission is to be composed as follows:
 - 1. There shall be five (5) voting members that comprise the Airport Arts Commission.
- B. Qualifications for Airport Arts Commission Membership
 - 1. The following criteria will be used for all membership appointments:
 - a. A Supervisor from each Supervisorial district shall nominate one (1) Airport Arts Commissioner.
 - b. Residency and Voting Requirements: Except where the Board finds it is in the best interest of the County to waive voter and residency requirements, all members of the Airport Arts Commission shall be:
 - i. registered voters in the County; and,

- ii. reside in the district of the nominating member of the Board of Supervisors, unless the Supervisor representing the district where the nominee resides provides written consent for the nomination.
- C. Length of Airport Arts Commission Membership
 - 1. All regular Airport Arts Commission member appointments shall be for a term concurrent with the term of office of the nominating member of the Board of Supervisors. A member of the Airport Arts Commission whose term of office is expiring with that of the nominating Supervisor shall have the option of reapplying for membership for appointment.
 - 2. Appointments made to fill a vacancy left by a member before the expiration of the term of that member shall be for the remaining term of that member.
 - 3. Pursuant to Government Code section 1302, a member whose term has expired shall continue serving as a member until reappointed or replaced.

ARTICLE V. <u>Airport Arts Commission Officers</u>

- A. Airport Arts Commission officers shall consist of:
 - 1. One (1) Chairperson and one (1) Vice Chairperson, each of whom shall be selected by members of the Airport Arts Commission.
 - 2. The Chairperson shall preside at meetings, call special meetings, decide points of order, announce all business, entertain motions, put motions to vote, announce vote results, appoint and may remove committee Chairpersons, represent the Airport Arts Commission at public functions. The Vice Chairperson shall perform the duties of the Chairperson in his or her absence. If the Chair becomes vacant, the Vice Chairperson shall succeed to the Chair for the balance of the term of office.
 - 3. Terms for officers of the Airport Arts Commission shall be for one year.
 - 4. No person, except a member of the Board, may serve as Chair of the Airport Arts Commission for more than three consecutive terms.
 - 5. No person, except a member of the Board, may serve simultaneously as Chair for two or more boards, commissions, or committees.
 - 6. Election of officers shall be held annually during the last Airport Arts Commission meeting of each calendar year by majority vote, a quorum being present.

ARTICLE VI. Duties of Members

A. Members shall attend meetings of the Airport Arts Commission and of committees to which they are appointed. The Executive Committee shall regularly review member attendance at the Airport Arts Commission and committee meetings.

- B. Members shall notify the Chairperson and Clerk of the Airport Arts Commission of any expected absence for a meeting by 5:00 p.m. of the day before a regularly scheduled Airport Arts Commission meeting, indicating good and sufficient reasons for the absence.
- C. In the performance of its responsibilities, the Airport Arts Commission shall not engage in nor employ any unlawfully discriminatory practices in the provision of services or benefits, assignment of accommodations, treatment, employment of personnel or in any other respect on the basis of sex, race, color, ethnicity, national origin, ancestry, religion, age, marital status, medical condition, sexual orientation, physical or mental disability or any other protected group in accordance with the requirements of all applicable County, state, or federal laws.
- D. Members of the Airport Arts Commission shall comply with the County Equal Employment Opportunity and Anti-Harassment Policy and Procedures.
- E. Members of the Airport Arts Commission shall comply with County Code of Ethics.
- F. Members of the Airport Arts Commission shall operate strictly within designated purposes of the Airport Arts Commission.

ARTICLE VII. <u>Committees</u>

- A. There shall be an Executive Committee comprised of:
 - 1. The Chairperson of the Airport Arts Commission.
 - 2. The Vice Chairperson of the Airport Arts Commission.
 - 3. Committee Chairs of the Airport Arts Commission.

The Executive Committee shall hold meetings at the request of the Chairperson. The Executive Committee shall review the Airport Arts Commission Bylaws and suggest amendments to the Airport Arts Commission in accordance with Article XII below.

B. Ad Hoc Committees: The Chairperson may establish ad hoc committees of less than a quorum of the Airport Arts Commission's membership to accomplish time-limited tasks that support the goals of the Airport Arts Commission.

Terms of appointment for ad hoc committees shall be for the period of time required to fulfill the ad hoc committee's purpose.

ARTICLE VIII. Meetings and Actions

A. The Airport Arts Commission shall, at its first meeting of each year, adopt a schedule of regular meetings and transmit that schedule in writing to members, the Board, and the public at large.

- B. All Airport Arts Commission meetings shall be open, public and noticed in conformance with the provisions of the Ralph M. Brown Act, California Government Code section 54950 et seq., as amended and held at a location within Orange County, California that satisfies the access requirements of the Americans with Disabilities Act.
- C. Special meetings of the Airport Arts Commission may be called either by the Chairperson or at the request of a majority of Airport Arts Commission members. Notice of special meetings shall:
 - 1. Be delivered to members personally, by mail or electronically, and must be received no later than 24 hours in advance of the meeting.
 - 2. State the business to be considered and whether alternative technological means may be used such as telephone or video conferencing, as technological resource availability permits and as permissible by the Ralph M. Brown Act.
- D. Quorum Requirements
 - 1. Quorum requirements are as follows:
 - a. General Meetings: Quorum shall be no less than 50 percent +1 of the membership.
 - b. Executive Committee: Quorum shall be no less than 50 percent +1 of the Committee membership. However, if there are unfilled vacancies in the membership of the Executive Committee, then the quorum requirement will be proportionately reduced.
 - c. Standing Committees: Quorum shall be the members present, but no less than three (3).
- E. Voting Majority: Decisions and acts made by majority vote of the members at any duly constituted meeting shall be regarded as acts of the Airport Arts Commission, except as otherwise provided by these Bylaws.
 - Members choosing to abstain from voting on specific actions will not affect majority requirements. Abstentions are considered a "non-vote" – neither a vote in the affirmative nor in the negative. However, in order for an action to be passed, a majority of the quorum casting votes must vote in the affirmative.

For example: If, at a standing committee meeting, six (6) voting members of the committee are present to vote, and on a particular motion, three (3) vote in the affirmative, two (2) vote in the negative, and one (1) member abstains, the motion passes.

- F. Voting by Proxy: Members of the Board and the County Executive Officer who serve as Airport Arts Commission members may designate a substitute to attend an Airport Arts Commission meeting on their behalf and vote on any action item by the submitting the member's signed proxy to the Airport Arts Commission Chairperson at the start of the meeting.
- G. Minutes: The Clerk of the Airport Arts Commission shall prepare and publish the minutes for each meeting of the Airport Arts Commission.

ARTICLE IX. <u>Removal and Resignation of Members</u>

- A. Removal: The Board may, at any time and without cause, remove any Airport Arts Commission member from office prior to the expiration of his/her term of office by majority vote of the Board.
- B. Resignation: Resignation of Airport Arts Commission members shall be effected by a written letter of resignation submitted to the Chairperson of the Airport Arts Commission and to the Board.
- C. The Chairperson shall notify the Clerk of the Board in writing of any vacancies within 10 days of learning the existence of any such vacancy.

ARTICLE X. <u>Authority</u>

- A. Parliamentary Authority: The Chairperson shall preside and manage Airport Arts Commission meetings using parliamentary procedure consistent with these bylaws, any special rules of order the Airport Arts Commission may adopt, and any applicable County, state, and federal law.
- B. When circumstances demand that action be taken before the next scheduled Airport Arts Commission meeting the Airport Arts Commission may authorize and grant its full authority to the Executive committee to act on its behalf to make specific, limited, independent recommendations to the County, a quorum of the Airport Arts Commission being present.
 - 1. Such actions taken on behalf of the Airport Arts Commission by a committee will be presented as an information item at the next regular Airport Arts Commission meeting.
 - 2. Such actions will not require further action by the Airport Arts Commission.
- C. Executive Committee When unforeseen circumstances demand that action be taken before the next scheduled Airport Arts Commission meeting, the Executive Committee is authorized to take action on behalf of the Airport Arts Commission.
 - 1. Airport Arts Commission members shall be notified either in writing or electronically within 72 hours of any such Executive Committee action.
 - 2. Such action is subject to review and ratification by the general membership of the Airport Arts Commission at its next meeting.

ARTICLE XI. Conflict of Interest

- A. Members of the Airport Arts Commission and any of its committees or subcommittees shall abstain from voting on any issue in which they may be personally interested to avoid a conflict of interest in accordance with County, state, and federal laws and shall refrain from engaging in any behavior that conflicts with the best interest of the County.
- B. Members of the Airport Arts Commission shall not vote nor attempt to influence any other Airport Arts Commission member on a matter under consideration by the Airport Arts Commission or any of its committees or subcommittees:

- 1. Regarding the provision of services by such member (or by an entity that such member represents; or
- 2. That would provide direct financial benefit to such member or the immediate family of such member; or
- 3. Engage in any other activity constituting a conflict of interest under County, state, or federal law.
- 4. If a question arises as to whether a conflict exists that may prevent a member from voting, the Chairperson or designee may consult with designated County staff to assist them in making that determination.
- 5. In order to avoid a conflict of interest or the appearance of such conflict, all nominees to become members of the Airport Arts Commission shall disclose on forms provided by the County information regarding their private economic interests that may be implicated by their service on the Airport Arts Commission.
- 6. Airport Arts Commission members shall timely file Statements of Economic Interests (Form 700) and other financial disclosures as required by law.
- 7. Airport Arts Commission members shall complete ethics training as required by County policy and Assembly Bill 1234 (Government Code sections 53234 through 53235.2).
- 8. Airport Arts Commission nor any of its members shall promote, directly or indirectly, a political party, political candidate, or political activity using the name, emblem, or any other identifier of the Airport Arts Commission.
- 9. No assets or assistance provided by County to the Airport Arts Commission shall be used for sectarian worship, instruction, or proselytization, except as otherwise permitted by law.

ARTICLE XII. Adoption and Amendment of Bylaws

- A. Adoption: An affirmative vote of at least 50 percent +1 of those voting, a quorum being present, shall be required to recommend these Bylaws for Board approval. These Bylaws become effective upon approval by the Board.
- B. Amendments:
 - 1. Any member of the Airport Arts Commission or the Executive Committee may propose amendments to these Bylaws.
 - 2. Proposed amendments shall be submitted in writing and made available to each member of the Airport Arts Commission no less than five days prior to consideration before a vote can be taken.

3. An affirmative vote of at least 50 percent +1 of those voting, a quorum being present, shall be required to recommend Bylaws amendments for Board approval. Any amendments to the Bylaws become effective upon approval by the Board.

ARTICLE XIII. <u>Severability</u>

Should any part, term, portion or provision of these Bylaws be determined to be in conflict with any law or otherwise unenforceable or ineffectual, the remaining parts, terms, portions or provisions shall be deemed severable and their validity shall not be affected thereby, provided such remaining portions or provisions can be construed in substance to constitute the provisions that the members intended to enact in the first instance.

ARTICLE XIV. Staffing Support

Staff support from John Wayne Airport shall be provided to support the Airport Arts Commission in conjunction with the work of the Airport Arts Commission.

Bylaws

ARTICLE I

Section 1. The official title of this Commission shall be the "John Wayne Airport Arts Commission." ARTICLE I. Name of Organization

ARTICLE II

MEMBERSHIP

Section 1. The John Wayne Airport Arts Commission shall consist of five (5) members. Each member shall be a resident of the County of Orange. One member shall be appointed to represent each of five (5) supervisorial districts. ARTICLE II. Establishment of John Wayne Airport Arts Commission

The members of the Airport Arts Commission are appointed by the Orange County ("County") Board of Supervisors ("Board") pursuant to Board Resolution No. 90-96, dated January 16, 1990.

ARTICLE III. Purpose and Functions

The purpose and function of the Airport Arts Commission is to advise and make recommendations to the Airport Director and Board regarding the development, finance, and administration of the Airport Arts Program.

ARTICLE IV: Appointment and Membership

ARTICLE III

APPOINTMENT

<u>Section 1.</u> The Board of Supervisors shall appoint the members of the John Wayne Airport Arts Commission. A Supervisor from each Supervisorial district shall nominate one (1) Airport Arts Commissioner. A member of the Board may appoint a person from outside of the District that the member represents, but may only appoint such a person with the concurrence in writing of the Board member who represents the District in which the proposed appointee resides.

ARTICLE IV

TERMS OF OFFICE

<u>Section 1.</u> The term of each member shall coincide with the term of office of the Supervisor from the District responsible for recommending his appointment. If, for whatever reason, a Supervisor leaves office prior to the completion of his regular term, the Commissioner initially recommended by that Supervisor, shall continue to serve on the Airport Arts Commission for the remainder of the term, at the pleasure of the incoming Supervisor.

<u>Section 2.</u> All members shall serve at the discretion of the Board of Supervisors. A member may have his membership terminated by a majority of vote of the Board of Supervisors. A vacancy thereby created shall be filled in the same manner as the original appointment.

ARTICLE V

OFFICERS

<u>Section 1.</u> The Officers of this Commission shall be:

A Chair, whose duties shall be to preside at all meetings and to direct and coordinate the activities and functions of the Commission;

A Vice Chair, who shall perform the duties of the Chairman in his/her absence.

<u>Section 2.</u> The Chair and Vice Chair shall be appointed for a term of one year by the Commission at the first meeting in September of each year.

ARTICLE V. Airport Arts Commission Officers

A. Airport Arts Commission officers shall consist of:

- 1. One (1) Chairperson and one (1) Vice Chairperson, each of whom shall be selected by members of the Airport Arts Commission.
- 2. The Chairperson shall preside at meetings, call special meetings, decide points of order, announce all business, entertain motions, put motions to vote, announce vote results, appoint and may remove committee Chairpersons, represent the Airport Arts Commission at public functions. The Vice Chairperson shall perform the duties of the Chairperson in his or her absence. If the Chair becomes vacant, the Vice Chairperson shall succeed to the Chair for the balance of the term of office.
- 3. Terms for officers of the Airport Arts Commission shall be for one year.
- <u>4.</u> No person, except a member of the Board, may serve as Chair of the Airport Arts Commission for more than three consecutive terms.

COMPENSATION

Section 1. Commission members shall receive no compensation.

ARTICLE VI. Duties of Members

- A. Members shall attend meetings of the Airport Arts Commission and of committees to which they are appointed. The Executive Committee shall regularly review member attendance at the Airport Arts Commission and committee meetings.
- B. Members shall notify the Chairperson and Clerk of the Airport Arts Commission of any expected absence for a meeting by 5:00 p.m. of the day before a regularly scheduled Airport Arts Commission meeting, indicating good and sufficient reasons for the absence.
- C. In the performance of its responsibilities, the Airport Arts Commission shall not engage in nor employ any unlawfully discriminatory practices in the provision of services or benefits, assignment of accommodations, treatment, employment of personnel or in any other respect on the basis of sex, race, color, ethnicity, national origin, ancestry, religion, age, marital status, medical condition, sexual orientation, physical or mental disability or any other protected group in accordance with the requirements of all applicable County, state, or federal laws.

ARTICLE VII

MEETINGS

<u>Section 1.</u> Regular meetings of the Commission shall be held on the first Wednesday of each calendar month at 9:30 a.m. Any meeting may be adjourned to a definite date by a majority of the members present.

Other meetings or hearings may be held as required, subject to the call of the Chair.

<u>Section</u> <u>2</u>. All meetings shall be open to the public. <u>ARTICLE VII.</u> <u>Committees</u>

- A. There shall be an Executive Committee comprised of:
 - 1. The Chairperson of the Airport Arts Commission.
 - 2. The Vice Chairperson of the Airport Arts Commission.
 - 3. Committee Chairs of the Airport Arts Commission.

The Executive Committee shall hold meetings at the request of the Chairperson. The Executive Committee shall review the Airport Arts Commission Bylaws and suggest amendments to the Airport Arts Commission in accordance with Article XII below.

B. Ad Hoc Committees: The Chairperson may establish ad hoc committees of less than a quorum of the Airport Arts Commission's membership to accomplish time-limited tasks that support the goals of the Airport Arts Commission.

Terms of appointment for ad hoc committees shall be for the period of time required to fulfill the ad hoc committee's purpose.

ARTICLE VIII

ATTENDANCE

<u>Section 1.</u> Regular attendance at meetings of the commission is required of all members of the commission to properly discharge its duties. A member absent from three consecutive regular meetings, without securing the consent of the Chair, shall automatically vacate the position. The Chair shall notify the Board of Supervisor of such action and request appointment of a new member to fill the unexpired term.

 - b. Executive Committee: Quorum shall be no less than 50 percent +1 of the Committee membership. However, if there are unfilled vacancies in the membership of the Executive Committee, then the quorum requirement will be proportionately reduced.
 - c. Standing Committees: Quorum shall be the members present, but no less than three (3).
- E. Voting Majority: Decisions and acts made by majority vote of the members at any duly constituted meeting shall be regarded as acts of the Airport Arts Commission, except as otherwise provided by these Bylaws.
 - Members choosing to abstain from voting on specific actions will not affect majority
 <u>requirements</u>. Abstentions are considered a "non-vote" neither a vote in the affirmative nor
 <u>in the negative</u>. However, in order for an action to be passed, a majority of the quorum casting
 <u>votes must vote in the affirmative</u>.

For example: If, at a standing committee meeting, six (6) voting members of the committee are present to vote, and on a particular motion, three (3) vote in the affirmative, two (2) vote in the negative, and one (1) member abstains, the motion passes.

- F. Voting by Proxy: Members of the Board and the County Executive Officer who serve as Airport Arts Commission members may designate a substitute to attend an Airport Arts Commission meeting on their behalf and vote on any action item by the submitting the member's signed proxy to the Airport Arts Commission Chairperson at the start of the meeting.
- <u>G.</u> Minutes: The Clerk of the Airport Arts Commission shall prepare and publish the minutes for each meeting of the Airport Arts Commission.

ARTICLE IX

QUORUM

<u>Section 1.</u> A majority of all members of the Commission shall constitute a quorum. A majority vote of a quorum shall decide all questions coming before it for decision.

ARTICLE IX. Removal and Resignation of Members

- <u>A.</u> Removal: The Board may, at any time and without cause, remove any Airport Arts Commission member from office prior to the expiration of his/her term of office by majority vote of the Board.
- <u>B.</u> Resignation: Resignation of Airport Arts Commission members shall be effected by a written letter of resignation submitted to the Chairperson of the Airport Arts Commission and to the Board.
- C. The Chairperson shall notify the Clerk of the Board in writing of any vacancies within 10 days of learning the existence of any such vacancy.

ARTICLE X

ORDER OF BUSINESS

<u>Section 1.</u> The order of business for all meetings shall be:

<u>Call to Order by the Chair.</u>

<u>Consideration of matters on the agenda.</u>

Any other business which may come before the Commission.

<u>Section 2.</u> Any party desiring to place desiring to place an item on the agenda must submit his request together with related materials, to the Airport Director not later than 5:00 p.m. on the Wednesday preceding the next regularly scheduled meeting. Exceptions will be allowed only when approved by the Chair or as provided by law.

Section 3. The agenda for meeting shall be posted at the County of Orange Public Information Office 72 hours before the meeting. Agendas for special meetings may be posted 24 hours in advance. With certain exceptions, no matter can be discussed or action taken thereon unless set forth on the posted agenda.

<u>Section 4.</u> There will be a public comment section on the agenda to provide, specifically, for member of the public to address the Airport Arts Commission during the meeting. ARTICLE X. Authority

- A. Parliamentary Authority: The Chairperson shall preside and manage Airport Arts Commission meetings using parliamentary procedure consistent with these bylaws, any special rules of order the Airport Arts Commission may adopt, and any applicable County, state, and federal law.
- B. When circumstances demand that action be taken before the next scheduled Airport Arts
 <u>Commission meeting the Airport Arts Commission may authorize and grant its full authority to the</u>
 <u>Executive committee to act on its behalf to make specific, limited, independent recommendations to</u>
 <u>the County, a quorum of the Airport Arts Commission being present.</u>
 - 1. Such actions taken on behalf of the Airport Arts Commission by a committee will be presented as an information item at the next regular Airport Arts Commission meeting.
 - 2. Such actions will not require further action by the Airport Arts Commission.
- C. Executive Committee When unforeseen circumstances demand that action be taken before the next scheduled Airport Arts Commission meeting, the Executive Committee is authorized to take action on behalf of the Airport Arts Commission.
 - 1. Airport Arts Commission members shall be notified either in writing or electronically within 72 hours of any such Executive Committee action.
 - 2. Such action is subject to review and ratification by the general membership of the Airport Arts Commission at its next meeting.

ARTICLE XI

COMMITTEES

<u>Section 1.</u> The Commission may appoint such committees as it desires. Appointments may be made by the Chair directly or upon motion of any member duly carried.

ARTICLE XI. Conflict of Interest

- A. Members of the Airport Arts Commission and any of its committees or subcommittees shall abstain from voting on any issue in which they may be personally interested to avoid a conflict of interest in accordance with County, state, and federal laws and shall refrain from engaging in any behavior that conflicts with the best interest of the County.
- B. Members of the Airport Arts Commission shall not vote nor attempt to influence any other Airport Arts Commission member on a matter under consideration by the Airport Arts Commission or any of its committees or subcommittees:
 - 1. Regarding the provision of services by such member (or by an entity that such member represents; or
 - 2. That would provide direct financial benefit to such member or the immediate family of such member; or
 - 3. Engage in any other activity constituting a conflict of interest under County, state, or federal law.
 - <u>4.</u> If a question arises as to whether a conflict exists that may prevent a member from voting, the Chairperson or designee may consult with designated County staff to assist them in making that determination.
 - 5. In order to avoid a conflict of interest or the appearance of such conflict, all nominees to become members of the Airport Arts Commission shall disclose on forms provided by the County information regarding their private economic interests that may be implicated by their service on the Airport Arts Commission.
 - 6. Airport Arts Commission members shall timely file Statements of Economic Interests (Form 700) and other financial disclosures as required by law.
 - 7. Airport Arts Commission members shall complete ethics training as required by County policy and Assembly Bill 1234 (Government Code sections 53234 through 53235.2).
 - 8. Airport Arts Commission nor any of its members shall promote, directly or indirectly, a political party, political candidate, or political activity using the name, emblem, or any other identifier of the Airport Arts Commission.

9. No assets or assistance provided by County to the Airport Arts Commission shall be used for sectarian worship, instruction, or proselytization, except as otherwise permitted by law.

ARTICLE XII

CHANGES IN THE BY-LAWS

<u>Section 1.</u> A majority vote of all members shall be required to amend these by-laws.

Proposed amendments may be placed on the agenda for consideration at any regular meeting. A copy of the proposed amendment shall be provided to each Commissioner within five days after it has been submitted.
 ARTICLE XII. Adoption and Amendment of Bylaws

- A. Adoption: An affirmative vote of at least 50 percent +1 of those voting, a quorum being present, shall be required to recommend these Bylaws for Board approval. These Bylaws become effective upon approval by the Board.
- B. Amendments:
 - 1. Any member of the Airport Arts Commission or the Executive Committee may propose amendments to these Bylaws.
 - 2. Proposed amendments shall be submitted in writing and made available to each member of the Airport Arts Commission no less than five days prior to consideration before a vote can be taken.
 - 3. An affirmative vote of at least 50 percent +1 of those voting, a quorum being present, shall be required to recommend Bylaws amendments for Board approval. Any amendments to the Bylaws become effective upon approval by the Board.

ARTICLE XIII

POWERS

<u>Section 1.</u> The John Wayne Airport Arts Commission in all matters is subject to the authority and jurisdiction of, and shall be advisory to, the Board of Supervisors. The Commission shall make recommendations to the Airport Director and Board of Supervisors regarding the development, finance and administration of the John Wayne Airport Arts Program. ARTICLE XIII. Severability

Should any part, term, portion or provision of these Bylaws be determined to be in conflict with any law or otherwise unenforceable or ineffectual, the remaining parts, terms, portions or provisions shall be deemed severable and their validity shall not be affected thereby, provided such remaining portions or provisions can be construed in substance to constitute the provisions that the members intended to enact in the first instance.

ARTICLE XIV. Staffing Support

<u>Staff support from John Wayne Airport shall be provided to support the Airport Arts Commission in</u> <u>conjunction with the work of the Airport Arts Commission.</u>
