

John Wayne Airport Fly Friendly Program 2023 Annual Report





2023 Program Results

This 2023 Fly Friendly report presents the second year of the program (January 1, 2023, through December 31, 2023). The Fly Friendly program uses robust data analysis, which includes aircraft noise monitoring system radar data and comprehensive operational data. This data highlights both General Aviation jet trends and individual operator performance for specific noise abatement analysis. It is quantified and translated into this annual report and scorecards, then publicized to the local community, industry organizations, and operators.



The following is a list of the highest-scoring operators by the program categories for 2023; Table 1 highlights the top three performers in each scoring tier category.

Results By Tier

The results are presented in four tiers divided by type of operation (Part 135 or N-Number) defined by the number of annual operations. The Fly Friendly program results for calendar year 2023 are presented in *Figures 1 – 4 for Tier 1 through 4*, respectively. In all the figures, those operators with high scoring values are highlighted in dark green; this is a score that is 90% or better. Operators with scores between 89-60% are shown in light green which represents "Compliant Scores" and operators with scores below 60% are shown in yellow which indicates "Low Scores."

Table 2 defines these scoring tiers.

Tier 1 Results: Top 15 Part 135 Operators by Annual Operations

The results for the top 15 Part 135 operators defined by the number of annual operations are presented in *Figure 1*. The operator with the highest score is **Verijet, scoring 94.0%**, which includes a perfect score for nighttime noise reduction, and near-perfect score for minimizing high noise events. In addition, this operator qualified for the Plus 10 Stage 5 category for operating an aircraft that generates lower noise. Of the 15 operators in this tier, Verijet scored in the Top Scores category and the remaining 14 operators scored in the Compliant Scores category. There were no operators in the Low Scores category.

Tier 2 Results: Top 16 – 30 Part 135 Operators by Annual Operations

The results for the Part 135 operators that were the top 16 – 30 operators defined by the number of annual operations are presented in *Figure 2*. The operator with the highest score is **Baker Aviation, scoring 90.4%**, which includes a near-perfect score for minimizing high noise events, as well as operating an aircraft that generates lower noise, qualifying them for the Plus 10 Stage 5 category. Of the 15 operators in this tier, Baker Aviation scored in the Top Scores category and the remaining 14 operators scored in the Compliant Scores category. There were no operators in the Low Scores category.

Tier 3 Results: Remaining Part 135 Operators with 24 or more Operations

The results for the Part 135 operators that had at least 24 operations per year (12 takeoffs and 12 landings) are presented in *Figure 3*. The operator with the highest score is **Global Jet, scoring 86.7%**, which includes a perfect score for nighttime noise reduction and a near-perfect score for minimizing high noise events. All operators scored in the Compliant Scores category, earning between 89%-60%.

Tier 4 Results: N-Number Operators with 24 or more Operations

The results for the N-number operators that had at least 24 operations per year (12 takeoffs and 12 landings) are presented in *Figure 4*. The operator with the highest score is **Robert & Karen Broderson**, scoring 99.0%, which includes a perfect score for nighttime noise reduction, and a near-perfect score for minimizing high noise events. In addition, this operator qualified for the Plus 10 Stage 5 category for operating an aircraft that generates lower noise. The operators scored in the top two – Top and Compliant – with the majority of the operators scoring in the Top Scores category.
