To advance our environmental stewardship, JWA has developed a Climate Action Plan (CAP) supporting reduction of greenhouse gas (GHG) emission as well as promoting other positive environmental outcomes by providing a wide range of co-benefiting policies. The CAP includes specific policies, programs and tools that the Airport deploys to support activities to reduce greenhouse gas emissions and to measure reductions. CAP measures are designed to balance the priorities of sustainability, reliability and cost-effectiveness. These measures broadly address reducing the Airport's environmental footprint through energy efficiency, potable water use reduction; emission reduction, and waste management, natural resource protection and coordination with tenants to correspondingly reduce their environmental impacts.

Significant programs JWA is implementing to promote GHG emission reductions include:

- Green concession and green project design and construction that support the use of sustainable materials, energy and water efficiency, and waste reduction.
- Clean Vehicle policies that support conversion to low emission vehicles and shuttles.
- Waste management programs supporting source reduction, recycling, organics composting, and food rescue to support the food insecure.
- Central Utility Plant and electrical upgrade program to support resiliency, reliability, and energy generation efficiency.

Since the development of a formal CAP in 2018 and implementation of internal tracking and reporting, JWA has reduced GHG emissions by 14%. JWA is now embarking on carbon accreditation as a roadmap to continue our REACH towards GHG reductions. JWA is committed to reducing Scope 1 and 2 GHG emissions annually to achieve a further reduction of 15% in Scope 1 and 2 emissions by year 2033 (versus reporting year of 2023), an overall reduction of 29% since 2018. This commitment advances the goals of environmental stewardship of JWA and the County of Orange.
